

**service tax on the services to and by education institutions** - service tax on the services to and by education institutions service provided by an educational institution all services provided by an educational institution to its students faculty and staff are exempt from service tax this means the fee charges collected towards admission tuition examination digital classroom transportation, **service tax on educational institutions caclubindia** - service tax on educational institutions according to clause i of section 66d of the finance act 1994 educational institution means an institution providing services by way of i pre school education and education up to higher secondary school or equivalent ii education as a part of curriculum for obtaining a qualification recognized, **service tax on construction for educational institutions** - he pointed out that in terms of section 65 105 ii b of the finance act service tax is liable to be levied only in respect of the construction made for the purpose of commerce or industry and the petitioner has admittedly provided construction for the educational institutions which would not fall within the above said definition in order to attract levy of service tax, **service tax on educational services caclubindia** - if any service is provided to an educational institution by way of renting of immovable property such service shall be outside the purview of service tax under clause 9 as an educational institution is required building playground parking lot canteen area etc in order to provide educational services, **brief on service tax on educational institutes taxguru** - the education department is exempted from payment of service tax on conducting examination and admission process through the agency the service tax was paid by the department to the agency and the agency deposited in the service tax department, **service tax exemption on educational services part ii** - service tax exemption on educational services part ii this is the case of works contract which is covered under section 66e h of declared services as per rule 2a ii of service tax determination of value rules 2006 in case of works contract entered into for execution of original works service tax shall be payable on 40, **how are the private educational institutions taxed as per** - if it is an approved education institution then the income is tax free but if it is not approved education institution then income is taxable at 30 on net profit approved means either register under 12a or 10 23c or approved from the education, **service tax mega exemption to educational institutes** - service tax exemption to educational institutes and auxiliary services as discussed previously a service is exempt from service tax if it is a part of negative list b covered under mega exemption c covered by specific exemption or d rendered in non taxable territory exemption under negative list, **eligible educational inst internal revenue service** - an eligible educational institution is a school offering higher education beyond high school it is any college university trade school or other post secondary educational institution eligible to participate in a student aid program run by the u s department of education, **education services under negative list service tax** - thus as per charging section 66b service tax shall be applicable on all services except negative list services or services which are specifically exempt from service tax section 66d of the finance act 1994 contains negative list of services the clause i of section 66d relates to education related services, **service tax on services provided to or by educational** - under the negative list era on the line of positive list scheme of service tax under finance act 1994 a specific entry has been incorporated under the section 66d of the said act i e negative list to exclude basic education from the scope of levy of service tax, **service tax exemption on services provided to educational** - services such as transportation catering security cleaning or house keeping admission or conduct of examination etc provided to educational institutions are exempt from service tax till 31st march 2017 from 1st april 2017 except services to pre school education and education up to higher secondary school or equivalent will attract service tax, **no service tax exemption to educational institutions from** -
